## 1 Terms of Agreement

### I hereby agree to the following:

- i. I understand that the daytime and evening programming services are run in different ways but adhere to the same standards and level of accountability.
- ii. It cannot be automatically assumed that content and presentation styles that are suitable on programme will be suitable on other programmes, and vice-versa.
- iii. This applies to the content, format, and music across the whole broadcast station, the website, and any social media content.
- iv. The editorial nature of some of the daytime programming, and therefore the Ofcom regulations may be different between different types of programming.
- v. I will not damage, tamper or interfere with any equipment owned by the radio station. Anything I damage will be paid for by myself.
- vi. I will always agree to the station code of conduct for presenters and volunteers.
- vii. I will not make any defamatory or negative remarks about the radio station, other presenters, or the management either on-air or off-air. Any issues which I have will be taken up with the management team.
- viii. I shall not promote any product, item, or event without express permission from the station manager. This includes, but is not limited to, anything not deemed "affordable for all" or any competing product or service such as, (but not limited to) alternate radio stations.
- ix. I understand expenses will not be paid unless expressly agreed in advance.
- x. I understand that any equipment that is given to me is a loan and that it always remains the property of the radio station. I am responsible for returning the equipment when no longer required or when requested.
- xi. If I have any grievance with another volunteer/member of staff, or I am unhappy with something about the radio station, I will let management know at the earliest opportunity in accordance with the appropriate policies.
- xii. My status is as a volunteer, not as unpaid staff member. I understand that I am not entitled to any staff benefits, including (but not limited to) sick pay, unfair dismissal claims, security of employment or any other such similar benefits that employees would receive. This agreement does not form a contract of employment.
- xiii. "The station" is currently the legal entity of Soar Sound CIC or any name that this entity may adopt in the future. I understand that my relationship is with this legal entity and no other, nor any individual.
- xiv. I cannot enter into any agreement with any third party on behalf of the station or the Soar Sound CIC without the express agreement of the board.
- xv. The station management may ask me to leave at any time. This will only happen following either a disciplinary hearing or an extraordinary board meeting, upon which a consensus opinion is met. I will be given seven days' notice of any such board meeting, which I can attend and challenge any such proposal, but the decision of the board will be final.
- xvi. I may only act within my remit, which will be clearly defined as a volunteer, unless otherwise agreed.
- xvii. I understand there shall be no food or drink within any studio, and this must be kept outside.All litter must be removed, and the studios left clean and tidy at the end of every use.
- xviii. I understand that if I breach the Ofcom regulations due to non-compliance of the documentation and training, I have been provided by SOAR SOUND and as a result the station receives a fine then I personally am liable to pay that fine. This documentation can include links to web content, such as Ofcom documentation.
- xix. I understand that the SOAR SOUND transmitter cannot be interfered with under any circumstances.
- xx. I agree to the above volunteer agreement and all other policies and procedures that shall be reasonably and timely implemented.
